

DIRECTIONS & PARKING OPTIONS

From Route 290 West:

Follow Route 290 West to **Exit 16**.

- At the end of the ramp, turn right onto **East Central Street**.
- Go straight through the next set of traffic lights.
- Turn left at the next set of traffic lights (facing the DCU Center) onto **Worcester Center Blvd.**
- At the next set of traffic lights take a right onto **Foster Street**.
- Go straight through the next set of lights, and then take the next right onto **Waldo Street**.
- Parking is available for \$2 per hour in the United Bank lot halfway down **Waldo Street** on the right.
- Walk out of the lot where you entered. The back of the Fuller, Rosenberg, Palmer & Beliveau, LLP offices will be facing you from across **Waldo Street**.
- Walk through the parking lot directly in front of you, and access **339 Main Street** via the gate at the bus stop next to Mechanics Hall.
- Take a left, and our front door is at **339 Main Street**.
- The Firm's reception area is on the left hand side of the front foyer.

From Route 90/Mass Turnpike and Route 290 East:

- Take **Exit 10** Auburn off of the turnpike to Route 290 East.
- Follow Route 290 East to Exit 16.
- At the end of the ramp, turn left onto **East Central Street**.
- Go straight through the next two sets of traffic lights.
- Turn left at the next set of traffic lights (facing the DCU Center) onto **Worcester Center Blvd.**
- At the next set of traffic lights take a right onto **Foster Street**.
- Go straight through the next set of lights, and then take the next right onto **Waldo Street**.
- Parking is available for \$2 per hour in the United Bank lot half way down **Waldo Street** on the right.
- Walk out of the lot where you entered. The back of the Fuller, Rosenberg, Palmer & Beliveau, LLP offices will be facing you from across **Waldo Street**.
- Walk through the parking lot directly in front of you, and access **339 Main Street** via the gate at the bus stop next to Mechanics Hall.
- Take a left, and our front door is at **339 Main Street**.
